What is a solar power purchase agreement (PPA)?

A solar power purchase agreement (PPA) is a financial contract in which a third-party developer owns, operates, and maintains the photovoltaic system, and a customer agrees to purchase the system's electric output from the solar services provider for an agreed-upon price and for a predetermined period.

How much energy storage was deployed in 2024?

Approximately 11.9 gigawatts (GW) of storage was deployed in 2024. In only the third quarter of 2024, and despite mounting concerns over potential trade and policy developments, the US storage market added a record-setting 3.8 GW of energy storage--an 80% increase compared to the prior year.
